 The Government of Nepal [GoN] has allocated funds and intends to apply part of the funds to cover eligible payments under the Contract for Katari Municipality Contract No: 04/Uda/Katarimun/076-077, Construction of 2<sup>nd</sup> line town planning footpath peti Nirman Karya & contract No 05/Uda/Katarimun/076-077, Construction of Hadaiya Baliya Khola Tatbandh Nirman Karya, Bidding is open to all eligible Nepalese Bidders.

- 2. Katari Municipality Office invites electronic bids and sealed bids from eligible bidders for the construction of 2<sup>nd</sup> line footpath peti Nirman and Hadaiya, Baliya Khola Tatbandh Nirman, under National Competitive Bidding procedures. Only eligible bidders with the following key eligibility criteria should participate in this bidding i.e. Form, Organization or Company Registration Certificate, Business registration License, VAT registration certificate, TAX Cleareance Certificate up to 075/076 and Declaration Letter
- 3. A complete set of Bidding Documents may be purchased from the office of Katari Municipality & Bidder who chooses to submit their bid electronically may down load the bidding documents for e-submission from PPMO's Web Site <a href="www.bolpatra.gov.np">www.bolpatra.gov.np</a>. Bidders, submitting their bid electronically, should deposit the cost (as specified above) of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. - 5. Electronic bids must be submitted to the office of Katari Municipality Office through PPMO website www.bolpatra.gov.np.egp on or before 12:00 on 17<sup>th</sup> magh 2076. Bids received after this deadline will be rejected & Sealed bids must be submitted to the office of Katari Municipality Office by hand/courier on or before 12:00 on 17<sup>th</sup> Magh 2076. Bids received after this deadline will be rejected.
- 6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00, on 17<sup>th</sup> magh 2076 (31<sup>th</sup> days) at the office of Katari Municipality. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security amounting to a minimum Mentioned below which shall be valid for 30 days beyond the validity period of the bid (i.e. 120 days).
- 7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
