The Government of Nepal [GoN] has allocated funds and intends to apply part of the funds to cover eligible payments under the Contract for Construction of Katari Municipality Pipal Chock Dekhi Kanchhi Bazzar jane Sadak Nirman Karya.Contract No: 1/Uda/Katarimun/076-077 Bidding is open to all eligible Nepalese Bidders.
- 2. Katari Municipality Office invites a sealed bids from eligible bidders for the construction of *Pipal Chock Dekhi Kanchhi Bazzar jane Sadak Nirman Karya* under National Competitive Bidding procedures. Only eligible bidders with the following key eligibility criteria should participate in this bidding i.e. Form, Organization or Company Registration Certificate, Business registration License, VAT registration certificate, TAX Clearance Certificate up to 075/076 and Declaration Letter.

- 5. Sealed bids must be submitted to the office of Katari Municipality Office by hand/courier on or before 12:00 on 12th Manshir 2076. Bids received after this deadline will be rejected.
- 6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00, 31th days at the office of Katari Municipality. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security amounting to a minimum Mentioned below which shall be valid for 30 days beyond the validity period of the bid (i.e. 120 days).
- 7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
