- 2. Katari Municipality Office invites sealed bids or electronic bids from eligible bidders for the construction of RCC Road under National Competitive Bidding procedures. Only eligible bidders with the following key eligibility criteria should participate in this bidding i.e. Form, Organization or Company Registration Certificate, Business registration License, VAT registration certificate, TAX Cleareance Certificate up to 073/074 and Declaration Letter

  - A complete set of Bidding Documents may be purchased from the office of Katari Municipality, Katari, Udayapur and by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of NRs. 3,000.00 Within 5th Asar 2075 within office hour. If so requested, the Bidding Documents can also be sent by post/courier services upon payment of additional cost of NRs. 500.00. However, the Employer will not be responsible for delay or nondelivery of the documents so sent.

- 6. Sealed bids must be submitted to the office of Katari Municipality Office by hand/courier. on or before 12:00 on 6th Ashad 2075. Bids received after this deadline will be rejected.
- 7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00, 6th Ashad 2075. at the office of Katari Municipality. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security amounting to a minimum of **NRS**. **72500.00**, which shall be valid for 30 days beyond the validity period of the bid (i.e. 120 days).
- 8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
